

§ 1. I am aware of the risks involved in speed competitions and special tests with automobiles and motorbikes in general, and I am aware that I put myself in particular danger, possibly danger of life, if I leave the allocated or designated areas, do not observe the rules and prohibitions or do not follow the regulations and instructions.

§ 2 I undertake to comply unconditionally and immediately with the regulations and instructions (written, verbal and visual) issued by the organiser and its representatives, the authorities and the police. I am aware that it is strictly forbidden to stay in front of the course boundaries (crash barriers, concrete elements, etc.), in restricted zones and on safety lanes and obvious danger points. I undertake not to enter these areas and other than the assigned or designated media reporter positions under any circumstances. The media reporter places expressly designated by the race management are noted on the course sketch. I will inspect these at the respective events. Spectator seats marked as such are also considered to be expressly allocated or designated places.

§ 3 You are only permitted to be on the service roads if you are wearing a media waistcoat. The waistcoat will be loaned to you by the organiser upon acceptance of your accreditation against a cash deposit of 100.00 EUR.

§ 3.1 The waistcoat may not be passed on to other persons. The media waistcoat is exclusively intended for press representatives.

§ 3.2 The waistcoat must be returned to the organiser at the end of the event. The borrower shall be liable for loss and/or damage to the waistcoat with the deposit paid.

§ 4 On the service roads, the emergency and rescue vehicles must always be given the right of way. The vehicles must not be obstructed

§ 5 Riding a scooter or e-scooter is permitted both in the paddock and on the service roads only if the rider has an official EURO MOTO scooter sticker. The number of stickers is limited to one per member of the press.

The stickers are issued once during the vest distribution at the first race in which the press representative participates and CANNOT be repurchased if lost. In the event of culpable violations of these regulations, the organizer is entitled to impose a contractual penalty of up to 250.00 EUR.

Helmets are mandatory when riding scooters/e-scooters within the paddock and on the service roads. Riding without a helmet will result in the permanent revocation of the sticker.

§ 6 Instructions of the organiser as well as his stewards or marshals are to be strictly observed.

§ 6.1 Disrespectful or insulting behaviour towards the aforementioned persons is to be refrained from.

§ 7 I am aware that the use of television and video cameras requires the written permission of the organiser. I shall be liable for any claims for damages asserted by the rights holders due to infringement of film and television rights.

§ 8 I am aware that any breach of my obligations under §§ 2 to 7 will result in the withdrawal of my press card, my waistcoat and expulsion from the event or the event site. In this case, the organiser is also entitled to sanction the infringement by withholding the deposit paid. The organiser reserves the right to assert further claims.

§ 9 I enter the rescue routes and/or the photographer's area at my own risk and waive all claims against the organiser, its vicarious agents and subcontracted third parties, the race track operator and the sporting organiser and its helpers for damages that I suffer as a result of my presence on the rescue routes and/or the photographer's area. Excluded from this are damages caused by grossly

negligent or intentional breaches of duty by the liable group of persons and for damages to life, body or health caused by negligent breaches of duty by the liable group of persons.

All visitors to EURO MOTO race events are obliged to comply with the house rules of the respective race track operators. These will be posted at the venue itself or can be accessed here (see section 9):
